<b>Interest Accrual</b>	<ol style="list-style-type: none"> <li>1. <b>Interest of personal large-denomination certificate of deposit shall accrue as of the date of successful subscription. Subscription application submitted on a public holiday or weekend will be processed on the first working day immediately after the end of such holiday or weekend.</b></li> <li>2. <b>The interest rate is fixed and calculated according to the annualized rate of return</b></li> <li>3. <b>Personal large-denomination certificates of deposit pay full principal and all accrued interest at maturity. Personal large-denomination certificates of deposit which fall due on a public holiday or a weekend shall become payable on the first working day immediately after the end of the holiday or weekend, except when such extension exceeds the maximum period for personal large-denomination certificates of deposit acceptable to the Bank or as regulated from time to time in which case the deposits will become payable on the working day immediately preceding the</b></li> </ol>		

	holiday or weekend.
<b>Early Withdrawal</b>	<ol style="list-style-type: none"> <li>1. Customers can wholly or partially withdraw personal large-denomination certificates of deposit before maturity. For partial early withdrawal, the remaining balance of the personal large-denomination certificate of deposit shall be equal to or higher than the minimum deposit amount required by the Bank. Under such circumstance, the deposit amount of such personal large-denomination certificate of deposit shall be changed to the remaining balance after early withdrawal and the interest accrual period shall remain unchanged.</li> <li>2. The Bank will pay interest on the deposit withdrawn before the due date for the actual deposit period at the rate (if any) determined by the Bank as applicable to a deposit (other than a time or call deposit) on the date of such early withdrawal, and, unless otherwise provided by laws, regulations and rules, the Bank furthermore reserves the right to recover a handling charge and the additional cost (if any) of obtaining funds in the market for the remaining period of the deposit.</li> <li>3. Customers shall visit our Branches/Sub-Branches or use Mobile Banking for partial withdrawal or full withdraw of the personal large-denomination certificates of deposit before its maturity.</li> </ol>
